

IVM/AFTER-SCHOOL- PLANS & PAYMENTS

IVM After-school starts with the first day of school and is a totally pre-paid program! It is on a first come, first served basis. All checks are to be made payable to IVM After-school with the child's name. There is a returned check fee of \$20.00 and participation in the program, including specials, is suspended until charges are paid. Any payment not received by due date may result in your child losing their spot in the program and a \$20 late fee will be charged.

OPTIONS:

ONE PAYMENT: This is a one time Cash/Check discount payment of \$1,300, due Aug 10, 10. Credit Card payment is \$1,350, due Aug.10. This gives you all the privileges and discounts of the Monthly option.

TWO PAYMENTS: The first Cash/Check discount payment of \$675.00. is due Aug.10, 10 and the second Cash/Check discount payment of \$675.00 is due Jan. 15, 10. Credit Card Payments of \$700/\$700 are due Aug.10.and Jan.15. This gives you all of the privileges and discounts of the Monthly option. Failure to make the second payment will result in nullification of any discounts.

MONTHLY: The Monthly option gives your child IVM/A-s every day school is in session for one continuous month. This program also gives the advantage of discounts for the specials which will be offered.

The Cash/Check discount payment is \$145.00 per month, Credit Card payment is \$150 per month. All methods of payment must be made by Aug.10 in order to participate in IVMS After-school on the first day of school. The first month is Aug. 23 - September 22. All monthly sessions run from the 23rd thru the 22nd of the following month and payment must be received by the 15th of each month. There will be a \$20 late fee for payments received after the 15th. In order to maintain our low rates, there are no allowances for holidays or non-school days.

BANKED: The Banked option allows you to use IVM/A-s as needed. You will prepay the program with a Cash/Check discount deposit of \$145.00. Credit Card payment for the deposit is \$150. The deposit is due by Aug.10. We will withdraw \$12.00 per day (vs. \$15 if no account is set up) of use for a total of 12 days. You will be notified when your account needs to be replenished. Payment for billed amount must be received within 7 days of billing date. Failure to do so will result in your child's dismissal from IVMS A-s until account is replenished. Account ends as of the last day of school and there will be no refunds.

SPECIALS: Specials are individually priced. The Calendar of Specials and pricing will be released soon after school begins. Specials will start the week of Sept 13.

OTHER INFORMATION: Student pick-up is 5:30. There will be a \$1.00 per minute late fee paid upon pick-up. If late fee not paid upon pick-up, fee is doubled. IVM After-School accepts Visa, MasterCard and Debit cards. Minimum payment accepted on card is \$15.00.
